### **OFFICIAL CONTEST RULES**

#### **HOW TO ENTER**

1. These rules pertain only to La Gran Tamalada de Seguin Competition!
2. Entry fees for the tamalada are as follows:
  - a. \$25 Tamalera(o) de Casa - Initial entry fee into one category
    - i. +\$10 each additional entry into each category
  - b. \$35 Tamalera(o) de Restaurante - Initial entry fee into one category
    - i. +\$10 each additional entry into each category
3. Limit (one) entry per person, per category. Any contestants wishing to compete in multiple categories must complete and submit an entry form for each category in which they want to compete.
4. Each tamale entry must be the original recipe and creative work of the entrant. No pre-made or third party recipes will be permitted.
5. Tamales must be approximately 1" thick, 2" wide and 4" in length. Please provide one dozen (12) fully cooked warm tamales for the official judging. Do not cut or alter tamale prior to submitting for contest.
6. One dozen tamales for judging must be submitted to La Gran Tamalada de Seguin table.
  - a. 2:30PM Tamaleras de Casa
  - b. 3:30PM Tamaleras de Restaurante
  - c. Any submission 15 minutes late or more will not qualify for entry. Any contestant who does not have their tamales fully cooked will be disqualified.

**ONLY 25 ENTRIES PER CATEGORY WILL BE ALLOWED TO ENTER THE CONTEST.**

#### **Tamale Varieties and Categories:**

- **Meat** (Examples: Pork, Beef, Chicken, Venison, etc.)
- **Speciality** (Examples: Bean/Cheese, Jalapeno/Cream Cheese, etc.)
- **Sweet** (Examples: Pineapple, Strawberry, Raisins, etc.)

#### **Judging Criteria:**

- Taste
- Creativity
- Appearance
- Filling and Aroma
- Texture of Masa

#### **Prizes will be given to each respective division:**

- Best Meat Tamale "El Gran Carnicero"
- Best Specialty Tamale "El Muy, Muy"
- Best Sweet Tamale "La Gran Dulzura"
- Best Overall Tamale "La Gran Tamal"
